All entries must be received by August 31, 2020. Judging will take place by September 8, 2020 and winners notified by September 30, 2020. No purchase of any kind is necessary to enter or win. Void where prohibited by law. Entry into this Contest constitutes your acceptance of these official rules and regulations.

WHO MAY ENTER

To be eligible for this contest, an individual must:

- Be a legal resident of Ontario, Canada; and
- Be 19 years or older at time of entry; and
- Be a current member of Kindred (personal, business or organization membership), this includes anyone employed by Kindred and members of their families.

CONTEST PERIOD

Entries can be submitted beginning June 1, 2020 and must be received by August 31, 2020 at 11:59 pm.

HOW TO ENTER:

- Address
- Telephone
- Home branch
- Brief description about your work, and tell us how your activity inspires hope and joy. (approximately 100 words)

Photo Requirements:

- Digital photographs only (no prints, slides, or negatives)
- Landscape orientation (for instance, 8½ inches high by 11 inches wide)
- File resolution must be a minimum of 300 dpi
- Minimum file size is 3300 x 2550 pixels
- JPEG file format

Entries not meeting the above requirements may be rejected. All entries become the property of Kindred and will not be returned. We respect your privacy and will not sell or trade your information to any outside parties. The personal information provided in the entry will only be used to administer the Contest or, by providing your email address, you consent to Kindred using your personal information from time to time, for marketing purposes, such as providing you information about our products, services, and/or community activities that may be of interest to you or the third party for whom you are acting. These emails will provide you with an option to change your consent at any time. You can also change your consent by calling or visiting your local branch.

All entrants must meet the eligibility requirements set forth in these rules in order to qualify for the prize. If the photograph you submit has identifiable people in it, you must submit signed photo releases for each individual or from their parent or guardian, if they are minors. Release forms are available on our website, or we can fax or email one to you.

You are responsible for ensuring you have the legal right to distribute the image, share the story, and enter it in this contest.

PRIZE

There will be twelve (12) cash prizes of \$100, one to each winning entry. Kindred will also make one (1) cash donation of \$500 to a Kindred partner organization supporting makers using their talents for good. The partner organization will be selected by Kindred Credit Union.

No substitution of prizes is permitted except by Kindred, in their sole discretion. Kindred reserves the right to substitute any prize with a prize of equal value for any reason whatsoever. The prize must be accepted as awarded and may not be transferred. All federal, provincial, and local laws and regulations apply. Kindred shall only be responsible for awarding the prize as stated in these official rules. Kindred expressly disclaims any responsibility or liability for injury or loss to any person or property relating to the delivery and/or subsequent use of the prize.

WINNER SELECTION

There will be twelve (12) winning photos selected from among all eligible entries received during the contest period. The odds of winning will depend upon the actual number of entries received.

The winner will be notified by email and/or by telephone. No correspondence will be entered into except with the selected winner. In order to win the prize, the selected participant must meet the eligibility requirements as listed in "Who May Enter" and "How to Enter" above and have complied with all other official rules and must complete, sign and return an affidavit of eligibility and liability and publicity release (waiver), where permitted by law within fifteen (15) days of receipt of prize notification or the prize will be forfeited and an alternate winner will be selected.

CLAIMING THE PRIZE
